

# District 5010 Rules for Inbound Students

*In consideration of the opportunity afforded to me by Rotary International District 5010 and my sponsoring Rotary Club to be an international exchange student for one year, I agree to the following:*

1. I will devote whatever time is necessary to learn English before departure to Alaska.
2. I will make every effort to get involved with my host family, school, and host club knowing that my efforts will make for a successful exchange.
3. I will participate in all Rotary meetings and functions as required by the Youth Exchange Officer of my Rotary Club or District.
4. This is a student exchange; I must attend classes and do my best to complete all of my classwork with passing grades.
5. I understand that I will not be granted a high school diploma.
6. I will ensure that I have all of the immunizations required by the school district that I will attend.
7. I understand that this is not a travel exchange and I am aware that District 5010 has a Travel Policy that I will abide by.
8. I will obey the laws of the host community and country and conduct myself in a manner to reflect credit to myself, my family, and my country.
9. I will not: smoke; use illegal drugs; or drink alcohol in violation of Alaska law.
10. I understand the use of drugs and/or alcohol is illegal and that I may be screened for possession or consumption of drugs or alcohol.
11. I will not drive a motor vehicle of any kind including, but not limited to, a car, JetSki, snow-machine, All Terrain Vehicle (ATV), etc.
12. I will not have an exclusive relationship with any one person or become romantically involved and will abstain from sexual intercourse or activity.
13. I will bring USD\$500 with me for an emergency fund. This money will be deposited into a controlled account immediately upon arrival and must be replenished if used during the exchange year. Any unused funds will be returned to me/my parents at the end of my exchange.
14. All expenses other than non-sport school-related are my responsibility, such as postage, clothes, etc.
15. All travel to and from my host city must be in confirmed status only, no standby status allowed. Return tickets must be changeable and valid for one year.
16. I will arrive on 2 August, 2019 in Anchorage, with a connecting flight to my host city on 11 August 2019. D5010 will provide detailed flight recommendations.
17. If I fly on a seasonal/charter airline such as Condor my parents will provide a USD\$1000 deposit to D5010 to cover the cost of a return ticket should one become necessary. If the funds are not used they will be returned to me/my parents at the end of my exchange.
18. Upon completion of my exchange I will return to my own country by the most direct route with no stops other than required by the airlines.
19. I will obtain a multiple entry visa for both the U.S. and Canada.
20. I understand that visits from my parents, legal guardians, siblings, friends or other family members are not allowed and will result in the termination of my exchange.
21. I understand that violation of any of the above rules may result in the termination of my exchange

**By signing this document, you and your parents/legal guardians accept that we collect, keep and use data about you, for the purpose of supporting your exchange. The information, including your full application, passport information, insurance, school reports and other documents will be accessible for Rotary officers related to your exchange year. This also includes permission for any report to Rotary International or Home District. Host families and schools will also be given information from your application. We will handle your information confidentially. You are entitled to receive information about the data we have about you, you may request it from the D5010 YE Chair.**
